HOST CITY: MIAMI

Greater Miami is synonymous with beautiful beaches and towering palm trees – but in its urban center, it's the cityscape of glittering skyscrapers over Biscayne Bay that gets all the attention. Diverse, dynamic and densely populated, Downtown Miami and the adjoining Brickell area is a hub of international finance, dining, arts and entertainment that no visitor should miss.

Despite its modern façade, this neighborhood has its roots firmly planted in the past, springing up along the banks of what is now known as the Miami River. Miami's first development boom started here in the 1900s, and icons such as the DuPont Building (Miami's only Art Deco skyscraper) and the Freedom Tower (where Cuban refugees were processed for entry into the U.S.) were raised in the following years. Today, the Freedom Tower is home to the Museum of Art and Design (MOAD) at Miami Dade College.

Downtown Miami's newest architectural icons — which do double duty as popular entertainment venues — include the contemporary art-focused Pérez Art Museum Miami (PAMM); the FTX Arena (home to the NBA's Miami HEAT); and the Phillip and Patricia Frost Museum of Science, which houses an aquarium and a 250-seat planetarium.

Visitors can easily get around Downtown Miami's compact core using CitiBikes, scooters and the Metromover (a free, air-conditioned elevated train). It winds through Brickell – where the shops at Brickell City Centre and Mary Brickell Village entice – and heads north to attractions such as the waterfront green spaces at Maurice A. Ferré Park and Bayfront Park, and to the shops at Bayside Marketplace, where the nearly 200-foot-high Skyviews Miami Observation Wheel offers panoramic views of Biscayne Bay. Bayside is also a hub for sightseeing bus tours and boat tours, which take passengers through the bay islands, fringed with palatial waterfront homes, many of them celebrity-owned.

Of course, a day of exploration requires fuel, and this neighborhood brims with appetizing options for lunch, happy hour and dinner. Dine at Area 31 on the 16th floor of the Kimpton EPIC Hotel or at La Mar by Gastón Acurio on the terrace of the Mandarin Oriental, Miami on Brickell Key, with spectacular views of Biscayne Bay and the skyline.



JEB BUSH

43RD GOVERNOR STATE OF FLORIDA

Governor Bush was the 43rd governor of the state of Florida, serving from 1999 through 2007. During his two terms, Governor Bush remained true to his conservative principles, cutting taxes, vetoing earmarks, and championing major reform of government programs. Under his leadership, Florida was on the forefront of consumer healthcare advances, led the nation in job growth, and launched and accelerated restoration of America's Everglades. In education, Florida raised academic standards, required accountability in public schools and created the most ambitious school choice programs in the nation. As a result, Florida students have made the greatest gains in academic achievement and Florida is one of a handful of states to significantly narrow the achievement gap. Prior to and after his tenure as Florida's chief executive, Governor Bush has been actively involved in the private sector, helping to build the largest full service real estate company in South Florida and owning and operating successful consulting and investing businesses. Governor Bush is also the Chairman and Founding Partner of Finback Investment Partners which is a private equity firm that takes active minority interest in middle market and growth-stage companies. Governor Bush maintains his passion for improving the quality of education for students by serving as the chairman of the Foundation for Excellence in Education, a national non-profit organization he founded to work with education leaders, teachers, parents, and advocates to develop and implement reforms that lead to rising student achievement. Governor Bush has written three books, Profiles in Character; Immigration Wars: Forging an American Solution; and Reply All: A Governor's Story 1999-2007. Governor Bush lives in Miami with his wife Columba. They have three children and five grandchildren.

MIKE EMANUEL

CHIEF WASHINGTON CORRESPONDENT FOX NEWS

Mike Emanuel currently serves as chief Washington correspondent for FOX News Channel (FNC). He joined FNC in 1997 as a Los Angeles-based correspondent. Emanuel reported live from the Capitol as it was mobbed by rioters on January 6th, 2021. Previously, Emanuel provided the latest breaking election news from Washington, DC during FNC's Democracy 2020 election coverage. Additionally, Emanuel has covered both the House and Senate proceedings surrounding both impeachments of President Donald Trump, lawmakers passing tax reform, the confirmation hearings for the Trump and Biden Cabinets, and the confirmation hearings for President Trump's three Supreme Court nominees. He also covered Secretary Hillary Clinton's 2016 presidential campaign. In his role, Emanuel has reported on key congressional races, the IRS scandal, the hearings surrounding the 2012 attacks in Benghazi, Libya attacks and President Barack Obama's 2012-2016 State of the Union addresses from Capitol Hill, among other events. During his tenure at FNC, Emanuel has provided live coverage of many national and international stories, including national elections, the 2005 Iraqi elections from Baghdad and the execution of former dictator Saddam Hussein. Emanuel has also secured interviews with top political figures including then-President George W. Bush and Vice President Dick Cheney, Senate GOP Leader Mitch McConnell and House Speaker Kevin McCarthy. On the Democratic side, Emanuel asked President Obama questions at news conferences and in the Oval office and has interviewed prominent Democratic lawmakers such as Senate Majority Whip Dick Durbin of Illinois and Maryland Democratic Senator Chris Van Hollen, and John Kirby from the Biden White House. Before joining FNC, Emanuel worked for KCAL-TV (CBS 9), a local independent station in Los Angeles, CA, where he covered breaking news. Prior to that, he covered local and state politics for KMID-TV (ABC) in Midland, Texas, KCEN-TV (NBC) in Waco, Texas and KTBC-TV (FOX) in Austin, Texas. Emanuel received a B.A. in communications from Rutgers University where he worked as a play-by-play radio announcer for Rutgers athletics on WRSU-FM (88.7 FM).

Mr. Branson is the CEO of AFIRE, an association for international real estate investors focused on commercial property in the United States. This group of institutional investors from 24 countries collectively manage approximately \$3 Trillion in commercial real estate assets. Previously, Mr. Branson was the CEO of NAREIM (The National Association of Real Estate Investment Managers). His real estate background includes leadership roles with GE Capital Real Estate and Heller Financial. He also consulted companies such as Jones Lang LaSalle, Wells Fargo, Wrightwood Capital, CIBC, and Fidelity on innovation, product development, and marketing strategies. Mr. Branson is a frequent speaker, for universities and professional groups, on television, and with TEDx, on the changing landscape of commercial real estate.



Dan Gelber is the 38th Mayor of Miami Beach. A U.S. Truman Scholar in college and law school, Dan served as a decorated federal prosecutor in South Florida. He was subsequently appointed by former Senator Sam Nunn to direct the U.S. Senate's prestigious Permanent Subcommittee on Investigations where he led investigations into fraud, waste and abuse in government and counterterrorism. He returned to South Florida and served a decade in the state legislature – House and Senate – where he was unanimously selected as the Democratic Leader. Dan practices law with the firm Gelber Schachter Greenberg LLP and is listed in Best Lawyers of America and is the only Florida lawyer to achieve the "Eminent Practitioner" ranking in his practice area in Chambers USA.
